On behalf of Community Assessment & Treatment Services, Inc. (CATS), we are proud to present our 2013 Annual Report. Thanks to our dedicated staff, Board of Directors and supporters, FY 2013 was a very successful year for CATS. We served more than 1,200 clients through our Intensive Outpatient, Residential and Cognitive Behavioral Therapy based programs as we continue to help the residents of Cuyahoga County battle substance abuse and mental health issues.

Also in 2013, we began a successful Capital Campaign to fund our 10,370 sq. ft., 60-bed addition to our residential facility. Led by a \$150,000.00 grant from the Cleveland Foundation, CATS successfully raised over \$300,000 in grants and donations towards the construction of this addition. A great big CATS "Thank You" goes out to The Woodruff Foundation, The Bruening Foundation, Third Federal Foundation, The Wolpert Fund, The Abington Foundation, KeyBank Foundation and the Ingalls Foundation for your generous support of our campaign. Because of these foundations and our individual supporters, and despite typical Cleveland weather, we were able to break ground for the addition in December, 2013.

As we look forward to FY 2014 and beyond, we look to expand not only our residential capacity but also the services we provide our clients and the agencies with which we partner. As the well-publicized Heroin Epidemic continues to ravage Cuyahoga County, CATS looks to focus on the Dually-Diagnosed and Opiate dependent populations with the 60 additional beds in our new building.

Another area we will focus on in FY 2014 is collaboration with other social service agencies throughout Cuyahoga County. Our work with The Alcohol, Drug Addiction & Mental Health Services (ADAMHS) Board of Cuyahoga County, The Cuyahoga County Office of Reentry (CCOR), Community Reentry (CR), Recovery Resources, Harbor Light and The Center for Evidence-Based Practices at Case Western Reserve University has proven invaluable to both our clients and our agency as a whole. We look forward to strengthening our partnerships with these agencies while exploring new collaborative partners for the future.

This year also marks 25 years serving the Cuyahoga County recovery community for CATS. To celebrate, we will be hosting a 25th Anniversary Gala on October 18, 2014. We hope to see as many of you there as possible. CATS is committed to providing the best alcohol & drug treatment and mental health services to those most in need throughout Cuyahoga County. Because of the hard work and dedication of our staff, our Board of Directors and YOU, our supporters, we have been able to provide these services for nearly 25 years and will continue to do so for years to come. For that, we thank each and every one of you.

Working at CATS is not glamorous. Responsibility and stress are high; prestige and financial rewards are not. Who are these people? Why do they do it?

Perhaps the most remarkable thing about CATS' staff is how much they enjoy their jobs. Outpatient Counselor, Kim Dubroc notes: "People like working at CATS and the clients know it." This is true across departments and disciplines. The 74 people who work at CATS are a diverse group of different ages, races, genders, religions and sexual orientations. They reflect the diversity of the consumers who participate in CATS programming and the communities we serve. Their styles and techniques differ, as Men's Residential Program Manager, Jeff Distin observes: "No matter what the situation is, we have different ways of doing it, but, we get it done." Their expertise is not just academic, it is often from life itself. Many staff members are in recovery from their own experiences with substances and criminal behavior, demonstrating CATS commitment to second

chances and the Staff's commitment to giving back.

There is a resilience that unites the staff in spite of their differences. "We don't give up" remarks Women's Residential Counselor, Linda Glasener. That stubborn spirit serves the staff and, in turn the consumers, well. Cuyahoga County is in the midst of a well-documented opiate epidemic. Funding is vulnerable and budgets are slashed. It would be very easy to throw in

the towel, yet CATS' staff is optimistic. Why? Kitchen Manager, William Brown explains: "You see it happening." "It" is the concept of recovery, the idea that hope always remains, the knowledge that things can and will get better. "It" is difficult to define but easy to see as clients change. "It" is clients proudly reporting: "I used my skills today." "It" is a former client calling their counselor to report a year of sobriety. "It" is another former client, stopping by to tell staff that he is not only enrolled in college, he is teaching there as well.

"It" is the stories of success that keep the staff at CATS going day in and day out as we help fight the disease of addiction.


